### C I R C U L A R

**Sub: Renewal of licence to purchase or acquire rubber for manufacturing -reg.**

Vide Govt. of India Notification No. GSR 1513(E) dt.13/12/17, the application in Form 'D' for renewal of licence has been amended so as to enable the manufacturers to apply for the licence for a consecutive period of 5 years. In order to apply online for renewing the licence for the period 2018-23, the manufacturers are requested to login the website: [www.rbegp.in](http://www.rbegp.in) using the user ID (Licence No.) and password already allotted. *The link: "Apply for fresh licence" provided in the home page is not meant for renewal of licence.*

After submitting the application online, a print out of the same which is set for a period of 5 years, duly signed, shall be sent to "The Dy.Director(ED), Rubber Board, Sub Jail Road, Kottayam-686002" so as to reach him on or before 31-01-2018. It may be noted that the software is being modified to enable renewal of licence for 5 years. Therefore, initially the licence will be renewed for one year and the validity will be extended automatically for the remaining 4 years when the modified software becomes operational, subject to receipt of the licence fee for 5 years.

The prescribed rate of licence fee is shown below (Revised as per Govt.of India Notification No.G.S.R.18 (E). Dt.08-01-2018, published in the official Gazette on 09-01-2018)

- For acquiring rubber not exceeding 4 MT per year : Rs.2950/- for 5 years (including GST @18 %)
- For acquiring rubber exceeding 4 MT per year : Rs.5900/- for 5 years (including GST @18 %)

Licence fee can be remitted by Demand Draft / At par cheque drawn in favour of the Director (L&ED), Rubber Board payable at Kottayam or by cash at Central Bank of India, Rubber Board Branch functioning at the Board's Head office at Kottayam. The amount can also be remitted in Rubber Board's Licensing & Excise Duty Account No. 3173717326 with Central Bank of India Kottayam-2(IFSC Code- CBIN0284150) through NEFT. A provision is also available for online payment through the link 'Pay online Rubber Excise Duty' available at the home page of the Website: [www.rbegp.in](http://www.rbegp.in)

Further it is informed that purchasing /acquiring rubber without having valid licence issued by the Board is an offence punishable with imprisonment or with fine or with both as per provisions of the Rubber Act 1947. Mere submission of application form for licence and remittance of licence fee to Rubber Board shall not be deemed that the applicant is a valid licence holder unless the licence has been issued by the Board in favour of the applicant. The licence will be issued with prospective effect only after satisfying all the formalities as demanded by the Board time to time. So please ensure that your licence is issued before expiry of validity of the present licence. Belated filing of application or incomplete application would delay the issue of licence, for which the Board will in no way be held responsible.
